Under an extension of the [Emergency Economic Stabilization Act](#), homeowners who install Panorama window film on their windows and glass doors are eligible for a credit of 10% of the cost, up to \$500.

Window film, considered an insulation material under the Act, offers proven energy-related benefits, including:

- Cost-effectively improving energy efficiency, helping to realize up to 30% in energy savings
- Decreasing carbon emissions by reducing the load on fuel-driven HVAC systems

To receive the residential tax credit for Panorama window film, consumers simply need to provide the following:

- IRS tax Form 5695 – Residential Energy Credits (reference Part 1, 2a)

- Copy of Panorama manufacturer's certification statement (obtained through the installing dealer or on the [Panorama Window Film website](#))

For commercial property owners, the deduction is available under the Energy Policy Act of 2005 (EPAAct), which has been extended for commercial buildings through 2013. The deduction equals the cost of the energy-efficient improvement, with a maximum deduction of \$1.80 per square foot. Window film is an ideal complement to other energy-saving products; it helps building owners meet energy-saving requirements and yields greater return on investment.
