



# Panorama® Optional Preferred Limited Warranty

Saint-Gobain Solar Gard LLC ("SGSG") provides the following supplemental warranty coverage to the Panorama® Window Films Limited Residential or Commercial Product Warranty in the event you purchase this additional coverage as set forth in section 2 below.

**1. Incorporation of Warranty:** The applicable Panorama® Window Films Limited Residential or Commercial Product Warranty (the "Warranty") is attached to this Optional Preferred Limited Warranty, and is incorporated herein in its entirety, with regard to the applicable SGSG Panorama® window films (the "Products"), as set forth below:

**Installation Type:**  Residential  Commercial  
**Film Type Purchased:**  Panorama® Solar Films  Panorama® Safety Films

**2. Additional Warranty:** If the installation of the Product indicated in section 1 expressly voids an original window manufacturer's glass or insulated glass (IG) unit seal failure warranty ("Window Manufacturer's Warranty"), and a warranted failure occurs to which the Window Manufacturer's Warranty would have applied, SGSG will pay the cost of replacing the window glass (containing the Product) with window glass of same or similar value and will also replace the Product on the new window glass; provided, that if the same Product is not available SGSG may replace with a similar product at its sole discretion (the "Optional Preferred Limited Warranty"). IN NO EVENT SHALL THE OPTIONAL PREFERRED LIMITED WARRANTY EXTEND BEYOND THE DURATION OF THE WINDOW MANUFACTURER'S WARRANTY OR EXCEED ANY REPLACEMENT VALUES OR ALLOWANCES AS DEFINED BY THE WINDOW MANUFACTURER'S WARRANTY'S TERMS.

**3. Warranty Period for Additional Warranty:** This additional coverage set forth in section 2 begins on the date this Optional Preferred Limited Warranty is purchased, and approved by SGSG, and extends for the warranty period of the Window Manufacturer's Warranty.

**4. Limitations:** The limitations set forth in section 5 of the Warranty remain applicable, except that:

**SGSG'S TOTAL LIABILITY UNDER THIS OPTIONAL PREFERRED LIMITED WARRANTY IS SUBJECT TO A MAXIMUM COMBINED WARRANTY CLAIM LIMIT OF \$1,000 ON A PER-WINDOW BASIS; AND THERE IS A DEDUCTIBLE OF \$50 PER WINDOW TO BE PAID BY CONSUMER.**

THIS OPTIONAL PREFERRED LIMITED WARRANTY IS NOT AVAILABLE IF THE WINDOW MANUFACTURER'S WARRANTY HAS EXPIRED PRIOR TO THE INSTALLATION OF THE PRODUCT OR IF THE WINDOW MANUFACTURER'S WARRANTY IS TERMINATED OR VOIDED UNDER ITS OWN TERMS.

SGSG shall only be liable for items expressly covered by the Window Manufacturer's Warranty, and this Warranty is subject to the terms and conditions contained in such warranty, including, without limit, the specified exclusions.

**5. How to Purchase this Optional Preferred Limited Warranty:** You must apply for this Optional Preferred Limited Warranty by submitting the application located at the bottom of this Warranty to SGSG, and paying an application fee of \$125 or of \$0.65 per each square foot of Product installed, whichever is greater. Upon SGSG's approval of your warranty application and payment of the foregoing fee, you will have coverage under this Optional Preferred Limited Warranty.

To apply for the Optional Preferred Limited Warranty, SGSG requires the following:

- (a) All parts of this properly completed warranty application (for validation stamping).
- (b) A copy of the Window Manufacturer's Warranty.
- (c) A copy of the work sheet indicating the number and location of:
  - (i) All windows covered by manufacturer's glass warranty.
  - (ii) All windows that will have Panorama® program window film installed.
- (d) A copy of the dealer's proof of purchase invoice (if installation has been completed).
- (e) An application fee check made out to Saint-Gobain Solar Gard LLC.
- (f) A copy of the film-to-glass application checklist (Catalog PDF0322PAN and located in the Dealer Corner on the website [www.panoramafilm.com](http://www.panoramafilm.com)) if applicable.
- (g) Send this Optional Preferred Limited Warranty application to:

**6. Repair:** All Optional Preferred Limited Warranty repair service must be made by a SGSG authorized warranty repair service provider and be approved by SGSG prior to service.

**7. Requirement for Application:** An application to purchase the Optional Preferred Limited Warranty must include all windows having Panorama® window film installed on them. Partial warranty coverage is not permitted, and voids this Optional Preferred Limited Warranty.

**8. Covered Persons/Companies:** If approved, the Optional Preferred Limited Warranty will be provided to and applies to, the person or entity named below. THIS OPTIONAL PREFERRED LIMITED WARRANTY IS NOT TRANSFERABLE.

**9. Application/Information:** You can apply for the Optional Preferred Limited Warranty for up to 30 days after the date of the Product installation. However, the Optional Preferred Limited Warranty coverage does not begin until SGSG approves and returns this Warranty to you, marked approved. In the event that an application is not accepted and coverage is denied, SGSG will refund the warranty application fee. SGSG reserves the right to reject any Optional Preferred Limited Warranty application for any reason which it deems, in its sole opinion, to be appropriate and reasonable.
